MESSAGE FROM THE PRESIDENT

Welcome to the 20th issue of the 2nd year of the President's News Digest.

I would like to start this edition by reminding colleagues about the deadline for submitting our HEC institutional accreditation application, which is due on 26 March. The application needs to be submitted in both Arabic and



English with all supporting materials in English including detailed CVs and job descriptions of the senior management and all academic staff, university catalogue, programme handbooks, staff and students' handbooks, marketing materials, and students' admissions forms. All documents need to be checked by their respected owners.

Last week, we heard from the HEC that our international research conference on sustainable futures, which will take place on the 26-27 November, will be held under the patronage of HE, the Minister for Education Dr Majed Al Nuaimi. This is fantastic news for the University and it is really timely considering that we will be going through institutional accreditation soon.

On the morning of 12 March, a panel from HEC visited to check our readiness to launch the Cardiff Met programmes. We are hopeful that they should allow us to do this soon.

On the morning of 13 March, the President chaired the Quality Assurance and Accreditation Council, which approved the submission of the three improvement plans for the College of Arts and Science. In addition, this council looked at various quality related issues including submission of course portfolios.

On the same day, the President attended a meeting chaired by the Secretary General of the HEC with presidents of private universities and senior officers from the HEC. The following is a summary of things that were discussed:



1. University Bylaws: alignment with HEC bylaws and submission by the end of March in Arabic and attested translated English version.



2. Internships are very important in delivering good quality education. Some guidelines regarding internships will be provided by the HEC following feedback from universities.

3. Students unified files are very important to ensure students issues are handled properly.

4. Issue related to equivalency and excess of 8 years in studying on a programme were discussed and there should be systems in place to identify students who are not able to graduate on time.

5. Employment of Full Time and Part Time staff needs approval by HEC. We need to have a pool of approved part timers.

6. Extra teaching loads are not allowed in the HEC Bylaws.

7. Recruitment of staff and placing adverts requests should be sent directly to Dr Mona Albalooshi.

8. Staff who attended the HEC HEA training should submit applications for HEA fellowships.

9. Universities should have staff development units in their organizational charts.

10. Importance of achieving full confidence for programme reviews was discussed.

11. Deadline for submitting institutional accreditation application to the HEC is 26 March.

12. Donations from private sector organizations need approval from HEC, the same applies when universities make external donations.

13. Master and Doctoral students' proposals need to be submitted to HEC who will be working on a template to facilitate this task.

14. All graduates details and related documents of the first semester of this academic year should be submitted to the HEC.

15: Various issues related to data requests, site visits by the HEC inspection panels, and other financialrelated issues were discussed.

On 15 March, the Chairman of the Board of Trustees, the President and Mr Yasser Abusenah met Ms Kathryn Harrison-Graves from the HEA in London in order to explore opportunities for further collaboration with the HEA. I am pleased to announce that more staff will be trained to achieve HEA fellowships. The President signed a consultancy agreement with the HEA to provide additional services, guidance and coaching in order to improve the area of teaching and learning.

In the afternoon of the same day, we visited LSBU and our office in London and explored with Prof Paul Ivey, Mr Andy Unger and Prof Charles Egbu opportunities to solidify our collaboration.



On 16 and 17 March, the Chairman of the Board of Trustees, the President and Mr Yasser Abusenah attended the Cardiff Met Partners Conference in Cardiff. Various papers covered the importance of quality assurance, strategic planning, marketing and need to create research capacity in academic institutions partnering with Cardiff Met. Cardiff Met announced the establishment of a new school of new technologies that include disciplines like digital media, data sciences and design technologies. During the visit, the ASU delegation had the opportunity to meet other partners to explore opportunities for collaboration and to share lessons learnt in running successful partnerships.



Let me conclude this edition of the News Digest by thanking our colleagues in Arts and Science, especially the Dean and the Vice Dean, the QAA Centre especially the Director, the 2 VPs, Mr Hatem and Mr Abdullah for all their help and dedication in submitting the improvement plans for the 3 programmes of the college on time. Let's now hope for a future successful visit by the Education & Training Quality Authority - BQA and to a good outcome.

ISO 9001:2015 CERTIFICATION: A NEW TESTAMENT OF ASU'S COMMITMENT TO TOTAL QUALITY



On 27 February 2017, ASU signed a Contract for Certification Services with RICI (Resource Inspections Canada Incorporated) to help install the ISO 9001:2015 quality system at the University's administration. This is yet 11:2015 another step by ASU to ensure the

quality of its operations and services not only at the academic level but also on the administrative front. Indeed, the certification efforts will include the following departments: Finance Department, HR Department, Administrative Affairs Department, Procurement and Logistics Services Department, ICT & KM Directorate, Deanship of Admissions & Registration, Quality Assurance and Accreditation Centre, Marketing and Public Affairs Directorate, Deanship of Student Affairs, Training and Continuing Education Centre, and the Community **Engagement Office.**

On the same day, a representative of the company, Mr. Rizwan Ahmad, was accompanied by Mr. Hatem Dammak to take the tour of the University and visit some of the departments that will be subject to the certification. He had a chance to talk to a number of our administrative staff to learn more about the procedures of each department. At the end of the visit, Mr. Hatem Dammak shared with him the administrative policies and procedures so that the company can review them and ensure their alignment with the ISO 9001:2015 standards. Next steps will include other visits to our premises and delivery of training sessions to key staff from the concerned departments.

Headquartered in Canada since 2004, RICI (Resource Inspections Canada Incorporated) is a leading company in certification services with branches in Bahrain, KSA and Pakistan. It helped other Bahraini Universities get the same certification. Mr. Hatem Dammak, acting Head of Internal Audit Unit was appointed to lead on this certification project.
