MESSAGE FROM THE PRESIDENT

Welcome to the 25th issue of the 2nd year of the President's News Digest.

I would like to start this edition by reminding colleagues that quality should be at the centre of all our activities in teaching and learning, research, and community engagement. Quality should be naturally embedded in our values and



should be achieved to the highest standards without even thinking about it. Only quality can drive the reputation and academic and financial performance of a university. Quality will help us deliver a top learning experience to our students using new and exciting methods of teaching taking advantage of technology advancements and new pedagogical approaches.

Student recruitment remains another important area and should be given the priority it deserves, especially for our new programmes with British Universities. We need to work collectively and exploit our network of contacts to help this very important area of the University. Our colleagues in Marketing and Public Affairs already visited many government schools and they started on Thursday visiting private schools. All private schools visits will be concluded by this coming Thursday. We have introduced mechanisms like "15% off tuition fee for foundation year only" and an incentive scheme whereby staff and existing students get rewarded for recruiting students on the new British programmes.

Last week, our staff and students have immensely benefited from 2 eminent academics namely Prof Tarek Heggy from King's College London and Prof Jacqueline Stevenson from Sheffield Hallam University in the UK.

Prof Tarek delivered a state of the art lecture to our staff and students in political science. The lecture covered the changes in international political landscape and its impact on the Middle



East. Our student Badria who is a Bahrain TV presenter led the discussion during the lecture. I attended part of this lecture and was impressed by the high intellectuality of our students and staff in raising important political issues affecting societies across the globe. The lecture took place on 17 April and was held at the University's Dome Hall.



On 18 April, Professor Jacqueline gave an excellent presentation about "Publishing in academic journals: tips to help you succeed". This is an important topic for us as we are trying to establish a strong research culture in our University. A very large number of staff estimated to be around 60



attended the lecture and appreciated the tips and learnt a great deal of good hints of how to get published. Producing strong refereed publications will undoubtedly enhance our efforts to achieve accreditation. I would like to thank Dr Faiza, Dr Adel, and Dr Bahaa for the efforts they put in organising these important lectures.



As we fast approach 1 May Labour Day, our students who are studying human rights in General Studies Department, under the supervision of Dr Rania, organised a celebration to recognise our cleaners, drivers and security personnel. Those colleagues working on the ground, make sure that our University is safe, secured, and clean. Their contributions are vital in providing a good image of our University. The good gesture and initiative by our students demonstrate their

kindness and willingness to apply what they have learned in the classrooms.

The celebration was attended by the President, Dean of Arts and Science, Dr Faiza, Dr Abdel Jabbar, Dr Murad (who gave an inspirational speech), Dr Amjad, Dr Rania (who led this initiative and the students work), Ms Ruqaya, Mr Hatem, Mr Maan, Mr Bahaa, Mr Ibrahim and 30 colleagues who are cleaners, drivers and security personnel, and over 100 students. RESEARCH SEMINAR SERIES

On 20 April, the Vice Dean of the College of Administrative Sciences, Dr Ramzi Nekhili, facilitated the research seminar series with a



presentation by Dr Hussein Khasharmeh on a research paper titled "Does the Provision of Non-audit Services Affect Auditor Independence and Audit Quality?". The seminar benefited from the presence of many faculty members discussing the topic presented. This seminar dealt with whether auditing firms can maintain their independence while providing non-audit services to audit clients.

Dr Khasharmeh explained that without independence, audit firms cannot achieve their goals, which is the basic requirement for an auditor to be able to perform an audit. In fact, the auditor in public practices must be free of bias with respect to client and must be recognised as independent by users of the audit report. Also, auditor independence is a cornerstone of the auditing

	Key Points











- The University will act as a good citizen by pursuing Community Engagement activities guided by a commitment to human values and a sustainable environment.
- The main objectives of the CE include: conducting field studies on Bahraini society to determine socio-economic problems, educational needs and barriers to development and envisage solutions; organizing training workshops, seminars and conferences; presenting volunteering and social engagement opportunities to the students and staff.
- The main duties of the CE Office Manager include: representing the CE Office with the relevant authorities; drafting contracts and agreements between the CE Office and the participating organizations; coordinating with various internal units and departments to facilitate and initiate community engagement activities; submitting an annual report to the University Council on the work of the CE Office at the end of each year. The VP for Administration, Finance and Community Engagement will approve the budget for the CE Office; review and monitor its publications, reports and periodicals; facilitate its activities with the other departments/directorates at the University and monitor and evaluate the success of the community engagement activities undertaken by the CE Office.
- The scope of activities under the CE Office has been divided into 4 categories:
 I. Employee Engagement: encouraging administrative and academic staff to contribute to CE activities and consolidate the culture of volunteerism amongst the students.
 - II. **Student Engagement**: coordinating with the Deanship of Student affairs to design and implement activities and events that help students become more aware of their society, improve their social skills and make them better equipped to serve their communities.
- III. **Scientific Engagement**: giving back to the Bahraini society by promoting research that focuses on real-world issues pertaining to the local and regional context such as water sustainability, environmental conservation, urbanization, or other pressing issues.
- IV. Industry Engagement: Collaborating with the "Career Development & Alumni Affairs", "Program Advisory Boards" and "Students Internship Units" to ensure that the University is able to maximize its interaction with the Industry and that the students are able to avail all the potential benefits of their service learning component of their curriculum.

REMINER OF THE WEEK

THE INSTITUTIONAL ACCREDITATION STANDARDS

AREA 3: Teaching, Learning and Assessment (4 Standards)



8. Teaching must be relevant to and effective in delivering the intended learning outcomes (7 KIs)

8.1. Teachers must be appropriately qualified in terms of subject knowledge, pedagogic and communicative skills, and experienced for the courses to which they are allocated.

8.2. Teachers must ensure that their delivery encourages the interactive participation of all students in classroom activities.

8.3. Teachers must use a mixture of large and small group and individual activities to encourage and support students' learning.

8.4. Teachers must direct students towards and encourage the use of supplemental learning materials and resources.



8.5. Teachers must produce schemes of work consistent with the syllabus, including detailed teaching session plans, and deposit these with the administration.

8.6. Teachers must draw upon their own research and that of others in their teaching.

8.7. Teachers must use appropriate learning resources effectively.

9. Learning opportunities provided must be varied and motivating and encourage students to develop as independent learners (6 KIs)

9.1. Intended learning outcomes must be appropriate for the level and nature of the program and course, paying particular attention to the requisite knowledge and skills required of graduates in the subject.

9.2. Intended learning outcomes for all programs must be articulated clearly and be publicly available.

9.3. The learning opportunities provided must be designed to facilitate students' achievement of the intended learning outcomes.

9.4. Students must be encouraged and supported to develop independent learning skills and take responsibility for their own learning.

9.5. Students must have access to teaching staff outside classroom-based teaching and learning sessions.

9.6. The institution must provide students with access to appropriate resources and materials for independent and group study and encourage and support their use of these.

10. Assessments must be planned, well-organized and be closely linked to the intended learning outcomes (8 KIs)

10.1. Students must be provided with an assessment schedule in which required coursework and revision periods are detailed in advance with clear submission dates.

10.2. The overall diet of assessments must include formative and summative elements and ensure that all program intended learning outcomes are addressed.

10.3. Individual assessments must focus on measuring student achievement of relevant intended learning outcomes.

10.4. The link between assessment and intended learning outcomes must be reviewed periodically to ensure relevance and effectiveness.

10.5. Assessment tasks must be clearly written, indicating by reference to the intended learning outcomes what the student needs to do to achieve stipulated levels of achievement.

10.6. Assessment procedures must be transparent so that students understand the link between marking criteria and grade attainment.

10.7. Students must receive prompt, detailed and supportive oral and written feedback on their assessments and overall performance and progress.

10.8. If final year projects are part of the program assessment, there must be a clear policy and effective systems for their assessment which are fair, transparent and relevant.



11. Assessments must be effectively administered and quality assured (6 KIs)

11.1. There must be secure and efficient procedures for the administration of examinations and other means of assessment, including the safe-keeping of assessment documents and records, and the provision of appropriate accommodation for conducting examinations.

11.2. The institution must take appropriate steps to identify and discourage cheating, including plagiarism and other misdemeanours, and to penalise offenders.

11.3. There must be clear policies and procedures for students to claim mitigating circumstances and to appeal against marks awarded within an appropriate, clearly stipulated timeframe.

11.4. There must be effective procedures for internal moderation at pre- and post-assessment stages.

11.5. There must be effective procedures for external moderation at pre- and post-assessment stages.

11.6. The institution must make student records and transcripts available to its students in a timely manner.
