PROGRAMME WITH LIMITED CONFIDENCE

As you are aware we are around two months away from the review for the limited confidence programmes which is a relatively short timescale. We need a plan to show how things will be managed before the visit which will include:

- 1. Readiness of course portfolios
- 2. Quality assurance auditing and activities





- 3. How the improvement plan is evidenced in some activities
- 4. Mock visit for our colleagues in preparing them for the review
- 5. The roles and visits of our external consultants as part of the preparation for the review
- 6. Scrutiny of mid term exams
- 7. Class observations
- 8. Any external reviews needed before the visit
- 9. Availability of Programmes Handbooks
- 10. Issues of plagiarism and Turnitin
- 11. Clear mapping of course and programme learning outcomes
- 12. Evidence of meetings of programmes advisory boards

PERFORMANCE APPRAISAL WORKSHOP

Randall S. Schuler, "Performance appraisal is a formal, structured system of measuring and evaluating an employee's job, related behavior and outcomes to discover how and why the employee is presently performing on the job and how the employee can perform more effectively in the future so that the employee, organization, and society all benefit."

ASU has decided to put in place a systemic process to appraise their employees, either academic or administrative.

Last Thursday, a workshop was held at Abdallah Nass Auditorium to present this process to the Academic Staff. All academic staff attended the workshop except those who had exams invigilation.

Employee Evaluation Policy and the new form of appraisal were presented and explained to the academic staff.

The main objectives of the new system are:

- To clarify the role and responsibilities of employees
- To clarify expectations and standards of performance
- To provide opportunity for two way communication and constructive feedback
- To raise awareness of strengths and areas for personal development
- To recognize achievement and develop a systemic process for promotions and incentive programs
- To reveal problems and inefficient work practices
- To provide opportunity to discuss and identify training needs







Performance evaluation ratings will subsequently be used to tie in the rewards/ incentives, compensation system and promotion criteria of the University.

The appraisal policy also defines a framework for employees who may wish to appeal against the final rating being assigned to them.

On top of this by implementing this policy and procedure, ASU will comply with the HEC Accreditation requirement (Indicator 4.12 "Management must monitor and review academic and administrative staff performance through a clearly documented and transparent appraisal system.")
