The debate about nature vs nurture has been around for a long time without reaching definitive conclusions. The nature versus nurtur

definitive conclusions. The nature versus nurture debate involves whether human behavior is determined by the environment during a person's life, or by a person's genes and whether particular aspects of behaviour are inherited or acquired through learning. The debate has gone to the extreme in some instances implying racist behaviour as some people argue that the IQs of certain races are higher than others because of heredity (nature).

Nature is influenced by genetic inheritance and other biological factors. On the other hand, nurture is generally taken as the influence of external factors such as life experiences and learning.

Human behaviour is influenced by both nature and nurture and this is reflected in personality, cognitive traits and temperament. The nature versus nurture debate can impact our behaviour in the academic sector and should be studied carefully as students are influenced by the personality, temperament and behaviour of their teachers and their abilities could be influenced by social factors and the way they were brought up.

Certain characteristics are observed at birth. However, it is how you are brought up (nurture) that governs the behaviour of people.

Some scientists stated that events in our childhood have a great influence on our adult lives, shaping our personality. In practice, hardly anyone today accepts either of the extreme positions, but the question of the balance of importance between the 2 aspects is that what needs to be studied.

This question was first framed by Francis Galton in the late 19th century. Galton was convinced that intellectual ability was largely inherited. However, others argue that intellectual ability is acquired and influenced by social inequalities.

The traditional way of studying nature versus nurture relies on identical twins as they share the same genetic code.

Their health and behaviour can be compared in order to determine whether genetic or environmental factors influence these two aspects. However, no firm conclusions were derived from many of the previous studies.

The importance of the subject of nature versus nurture in academia is paramount. This can also influence the concept whether leaders are born or made. It is widely known that a couple of theories emphasise that some people who are born with specific traits and characteristics will make them potential future leaders. However, some other theories stipulate that leaders are made through development and training and learning. The fact is that leaders can be born or made or both and this will influence the way academic leaders are chosen as they have the responsibility to promote a culture of learning and development and equal opportunities for all irrespective of whether some students are born with high intellectual ability or not. All students have the right to study and it is our duty to encourage them to do so. The social and domestic/home conditions (broken families, financial struggle, etc) can in some cases influence their academic performance, but it is our duty to create the right conditions at the University in order to unlock their potential and help them

The conference was chaired by Professor Mahmoud Abdel Aty, Former Dean of Research and Graduate Studies at ASU in the

presence of the Secretary General of the Association of Arab Universities and many universities presidents and an audience of around 150 researchers and scholars.

The President delivered a speech at the opening ceremony of the conference highlighting the importance of publishing in journals indexed in ISI and Scopus databases. He also highlighted the importance of joint research and publications between



universities and researchers. In his keynote address, he spoke about the ASU success story and how research has helped to put the University on the international map. There were various presentations by Elsevier and Universities Presidents who highlighted the importance of publishing and scientific research and many presentations covered the subject of universities rankings. Lessons learnt from the conference:

- Publish in top rated journals in your field
- Publish jointly with colleagues from other Arab Universities
- Research is a privilege and usually successful researchers conduct research in their spare time
- The Journal impact factor is an indicator of its quality
- Networking at conferences will always help the University in profile raising
- Universities league tables are usually based for their research component on papers published in Scopus and ISI listed journals.


