The Evolution of Internal Audit in the Higher Education Sector

The Institute of Internal Auditors defines internal auditing as, "an independent, objective assurance and consulting activity designed to add value and improve an organization's operations. It helps an organization accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control, and governance processes." By its very definition, internal audit activity is intended to enhance the organization, not play "gotcha" politics.

Historically, internal audit (IA) was traditionally focused on assuring financial integrity and detecting any fraudulent behavior (Arena, 2013). Its scope has later expanded to assure compliance with the various laws and regulations of the sector in which the organization operates. More recently, the internal audit function has further evolved to become a powerful tool of continuous improvement and development that aspires to improve the efficiency and efficacy of the organization's operations, anticipate risks, seize opportunities and achieve strategic goals (Lettieri et al., 2009).

In the higher education sector, we can say that the IA function was introduced later than many of the other sectors, thus it is still somewhat under-researched, but its role has proven increasingly important as Higher Education Institutions (HEIs) are trying to navigate an environment full of new risks and challenges of regulatory, financial, operational and reputational nature. Perhaps the most famous scandal in higher education that was heavily covered by the media is a nationwide college admissions bribery scandal at several top American universities. The scheme was uncovered in March 2019, but it actually happened several years ago. The reputational damage was massive, and I can't help but think that if the involved universities had better and stronger IA mechanisms, they could have avoided this accident.

Hatem Dammak is a Tunisian Higher Education Professional with 10 years of experience. He has a Bachelor of Engineering from ENIS (Ecole Nationale des Ingénieurs de Sfax) and is currently pursuing his MBA at Strathclyde University. He achieved his Lead Auditor Certificate in 2017 and his AFHEA status in 2019. He used to work at the Mediterranean School of Business (www.msb.tn) before joining ASU in November 2016.

The evolution of the role of IA at HEIs was captured by a study conducted by 2 researchers at the University of Texas at Tyler. They surveyed 356 universities (members of ACUA: Association of College and University Auditors, founded in 1958) to detect the types of audits conducted, which showed a noticeable evolution. In fact, over 20 years ago, a similar survey found that almost half of ACUA member institutions performed no performance or operational audits, focusing primarily on issues related to financial integrity and regulatory compliance. Survey results show that a greater percentage of today's ACUA members (2019) are involved in higher-level audits. As shown in Table 1 below, all respondents, both private and public institutions, are now engaging in operational and/or performance audits (31.5% and 30.7% of audit hours, respectively), which was previously not the case.

Here at ASU, under the guidance and encouragement of the University's inspiring leadership, the Audit & Compliance Unit tries to strike a balance in its auditing activities to both ensure compliance with the different regulatory bodies (HEC, BQA, LMRA, etc.) and explore improvement opportunities with regard to the University's operations, control mechanisms, policies and procedures, and governance. Furthermore, I am personally interested in advancing the research around internal audit as a function within the universities based in Bahrain in particular and the GCC countries in general, which could be the subject of a research paper in the future.

The Art and Science of Teaching and Learning

Teaching and learning have always been hot topics, especially in recent years. The old days of traditional teaching are over. The broadcasting/spoon feeding model is no longer appropriate. Recent conversations and discussions in this area are all about how the art of teaching can meet the science of learning. In fact teaching (and learning) is in part art and in part science. The science part is related to:

- Developing rigorous and relevant courses and academic programmes with clear learning outcomes
- Developing assessment methods to measure the achievements of the learning outcomes
- Embracing models like Bloom's Taxonomy to design learning outcomes and their appropriate assessment methods
- Following NQF National Qualifications Framework) frameworks to position learning outcomes at the right levels

The art is related to:

- The delivery methods which should be exciting using a variety of teaching tools and embracing technology
- The ability to orchestrate a vibrant and supportive environment taking into account the students' abilities, their psychological and behavioural needs and their learning styles
- The layout and design of the classrooms by embracing basic techniques to make them look welcoming.
- A teacher/instructor should master their subject areas (science). However, it is also important to have the right delivery methods and engagement with students (art).
- The quality of teaching and learning is usually reflected in typical statements by students.

Typical positive statements you hear after a lecture/class include:

- It was inspirational setting the vision for the subject area
- It was exciting and full of good ideas and positive participation
- The lecturer was amazing by being dynamic creating a vibrant learning environment
- For the first time, I started to understand this subject
- The lecture room was really welcoming
- The content was at the right level
- The PowerPoint slides were clear with the right number of bullet points and text
- The use of a variety of methods including videos, etc was very useful
- The lecturer was clear about the learning outcomes that will be achieved and how they will be assessed
- I like the way the lecturer split us into groups and encouraged us to think critically and to learn from each other
- I will definitely take another subject with this lecturer
- I liked it when the lecturer said, please come to my office during office hours for any further help
- I can't wait for the next lecture

Typical negative statements after a lecture/class include:

- It was monotonous and boring
- The lecturer was sitting on the chair and reading the slides throughout the lecture
- The lecturer didn't have any eye contacts during the lecture
- The content was good but the delivery was bad
- I didn't understand what learning outcomes I would achieve
- The content was not right for a final year class
- This lecture was really boring in comparison with the other one, the lecturer kept reading from the book
- The PowerPoint slides were full of spelling mistakes
- I wish I didn't take this subject and this lecturer
- The lecturer kept wasting our time by telling stories which are not relevant to the course
- This lecturer doesn't understand that he/she is teaching digital natives, his/her use of technology was really primitive, couldn't make the font bigger on the slides.
- This is my very first semester and the lecturer was really harsh
- The classroom setup was not right for a good and dynamic learning environment
- God helps us it is the same lecturer of last week

Delivering an exceptional teaching and learning experience to our students depends entirely on us as educationalists. We need to create a culture of quality and excellence coupled with strong leadership in order to provide our students with a supportive environment that will make learning really interesting.


A passionate lecturer will produce excellent lecture notes based on the course specifications and lesson plans. He/she will also be passionate about delivering state of the art lectures that meet the specified learning outcomes using a variety of methods. In addition, he/she will produce course portfolios of the highest quality containing samples of lecture notes, assessed work, and reflective statements amongst many others. He/she will ensure that the students are taught and assessed at the right levels taking into account NQF requirement and Bloom Taxonomy revised model.

Some tips to be a good lecturer are listed below:

- Be prepared, your students are looking forward to be educated by you through your knowledge and experience. You need to
 demonstrate that you are the master of the class and that you have the competencies and skills needed, they are observing you
 during the entire lecture
- Be firm and assertive to ensure that they are taking learning seriously. However, there is a fine line between assertiveness and harshness, you need to demonstrate empathy and provide all the support needed
- Be a leader by controlling your class and managing time properly. It is vital that you lead by example by demonstrating that you are turning up on time and by fulfilling your commitment to complete your class and cover the learning outcomes
- Be inspirational, your students see you as a role model. They want to listen to a performer who makes teaching exciting and their learning deep and interesting
- Be creative and teach in a variety of ways. Avoid to be monotonous and predictable and ensure that you are using relevant technologies to make your lessons more interesting and engaging
- Be passionate as our profession of teaching and field of education require passion in everything we do. A passionate lecturer will create a buzzing environment where learning can flourish
- Be fluent in using and understanding Bloom Taxonomy: academic's knowledge of Bloom Taxonomy is vital in order to design learning outcomes and assess them at the right levels. Success in Programme Reviews and NQF related activities depends on study plans, learning outcomes, and assessment of learning outcomes reflected in good quality course portfolios. It is disastrous to use verbs like define and explain in the final years of an academic programme; in the final year the questions will be mainly based around the verbs create, formulate, etc. Just to remind everybody the levels of Bloom Taxonomy are: Remember, Understand, Apply, Analyse, Evaluate, Create (RUAAEC), in the first years of an academic programme it is about remembering, understanding, defining, listing and applying knowledge whereas in the final years it is all about critically analysing, evaluating, formulating and creating aspects of knowledge.

To conclude, change is the only constant in our lives and as academics and administrators we need to embrace the change. The change in students demands, market demands, different type of skills, teaching methods, teaching pedagogies, technology, quality, etc should be taken into account and staff development should play a major part in educating colleagues about changes in the teaching and learning areas.

achieved during their course of study.







